- Any discrepancy in the invoice shall be intimated within 7 days of receipt at the email ID mentioned on the invoice any correction shall be carried out by Debit note / Credit note.
- The customer agrees to pay all invoice/s within **30** days from the date of invoice submission. Upon failure to pay the same interest, @18% per annum. The Customer shall settle the Invoices raised by BOX 'N' FREIGHT without any deduction.
