Chargeable Weight:

- The volume will be converted into weight based on the formula 1 CFT = 7 kg and the charged weight will be arrived at by considering the actual or converted weight whichever is higher.

Value Surcharge (FOV):

Value surcharge will be charged 0.1% on the invoice value or minimum 100/- on your invoice value (At Owner risk).

 Box N Freight Logistics Solutions Pvt. Ltd. liable to provide COF (Certificate of Facts-Subject to remarks on POD), within a stipulated time frame of 15 days, from the date of dispatch.

Company's liability is Rs 7500/- paid separately through different cheque, in case of any loss or damage and provided there is a delay in rising of the COF.

Docket Charge:

• The fixed printed transaction charge will be Rs. 100/- per docket.

Green Surcharge:

 Additional Rs. 100/- per docket will be charged for any consignment delivered or picked up from Delhi, Ghaziabad & Noida.

Surcharge

• Surcharge is calculated at 15 % of the Basic Freight.

GST (Goods & Service Tax)

• GST is charged on total freight @18%, subject to revision as per GST Act.

Annual Revision:

• This revision shall be done as per the mutual consent.

VALUE ADDED SERVICES

DOD / DACC & Hub Delivery Charges:

- This is a value-added service, which enables you to recover your Sales Proceeds.
- Our DOD (Draft on Delivery) Service will enable you to get a Demand Draft/Cheque from your customer through our system. We will collect the same before delivering the consignment and will send you the same in the shortest possible time, usually It will take 7-10 days, after delivery to send DOD (Demand Draft on Delivery/COD (Cheque on Delivery) – Not Required.
- If you opt for our DACC Service we will deliver by collecting the Consignor's copy of the Docket. – Not Required.
- Hub Delivery offers your customer the flexibility to collect the consignment from our nearest hub directly. Not Required.
- The Service Charge applicable will be Rs. 500/- per docket Not Required.

ODA Charges: Apart from delivering to the destinations under our scheduled network, we also deliver to other locations covering the entire nook & corner of the country. For catering to the locations serviced under our ODA Service we charge the following over and above the normal freight applicable to that State. Any location, if added to our scheduled network, you will automatically get the benefit of the rate applicable excluding the ODA Service Charge:

ODA 1 Charges- Rs. 1500/- or Rs. 5 per kg whichever is higher per docket. ODA 2 Charges- Rs. 2500/- or Rs. 10 per kg whichever is higher per docket.



Package Handling Charges:

 1 Box/Piece up to 100 kg will be charge NIL & above 100 Kg it will be Rs. 5 per Kg, extra

BILLING, PAYMENT & TAX:

- > BOX 'N' FREIGHT shall raise and submit the Tax invoice (e-billing) once in a month basis for the services rendered by it.
- Any discrepancy in the invoice shall be intimated within 7 days of receipt at the email ID mentioned on the invoice any correction shall be carried out by Debit note / Credit note.
- The customer agrees to pay all invoice/s within 30 days from the date of invoice submission. Upon failure to pay the same interest, @18% per annum. The Customer shall settle the Invoices raised by BOX 'N' FREIGHT without any deduction.
